The applicant is looking for approval to modify the approved landscape plan for sections 10, 11 & 12 of Greenwich Crossing. The proposed modifications relate to the evergreen buffer plants and street trees for nine lots with the approved subdivision. The nine lots in question are and have been occupied for the last three years or more. The developer has attempted to complete landscaping as approved, however there are nine owners of single family homes in the development who do not want plants installed on their properties as approved as part of the major subdivision approval. The applicant is seeking to amend the approval to modify the requirement for landscaping, to satisfy the homesowners in a way that is acceptable to the Township.

Dale Archer made a motion to approve amendment waiver design standard regarding trees. Wilfredo Rojas made the second.
