AUTHORIZE TOWNSHIP ENGINEER TO PROCEED WITH APPLYING TO NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION FOR MODIFICATIONS TO ALLOCATION PERMIT ON THOMPSON FAMILY PARK IRRIGATION WELLS

By motion of Mr. Grant, seconded by Mr. Giordano, the above be approved.

DELINQUENT UTILITY ACCOUNTS

Discussion was held with the Public Works Manager Anthony Rossett regarding the proposed procedure regarding the above. It was proposed that any resident two quarters or more past due should receive a delinquent notice. In that notice it will advise resident they have 30 days to pay before service will be shut off and will be required to pay a shut off/turn on fee and that payments will only be received during regular business hours.

Regarding residents not yet tied into service on Rattling Run Road, letters were mailed on July 13, 2012 and they have six months in which to tie in or they will be charged 1.5% interest per month and a quarterly penalty until connected. The amount of the quarterly penalty has not yet been established.

There being no further business, by motion of Mr. Giordano, seconded by Mr. Grant, the meeting adjourned at 8:30 p.m.
