Anne Danilak of 19 Stone Ridge Drive, Mickleton NJ discussed her frustration why no flashing light or any type of caution for the crossroads of Democrat Road and Swedesboro Avenue has been put in place. Mayor Archer explained that Democrat Road is a county road and would be responsible for making that decision. The county has completed a 5 year study; but the county has expressed no indication of a reason to install any type of light or cautionary feature at the crossroads. Mayor Archer also stated to Ms. Danilak to reach out to the County Planning Board, and attend a county meeting to discuss her issues since it is a county matter; and was given information for the county.
